ORDINANCE NO. 5-2011

AN ORDINANCE OF CITY OF MONONGAHELA, PENNSYLVANIA, AUTHORIZING THE CITY COUNCIL OF CITY OF MONONGAHELA TO ENTER INTO AN INTERGOVERNMENTAL COOPERATION AGREEMENT AND ESTABLISH MEMBERSHIP IN THE MID MON VALLEY INTERGOVERNMENTAL COOPERATIVE, AND ESTABLISHING THE CONDITIONS OF SAID MEMBERSHIP PURSUANT TO THE REQUIREMENTS OF PENNSYLVANIA CONSOLIDATED STATUTES, TITLE 53, SECTIONS 2301 THROUGH 2315, COMMONLY KNOWN AND REFERRED TO AS ACT 180, INTERGOVERNMENTAL COOPERATION LAW, AS AMENDED, OF THE COMMONWEALTH OF PENNSYLVANIA

WHEREAS, Pennsylvania Consolidated Statutes, Title 53, Sections 2301 through 2315, commonly known and referred to as Act 180, Intergovernmental Cooperation Law, is the law governing intergovernmental cooperation within the Commonwealth of Pennsylvania; and

WHEREAS, CITY OF MONONGAHELA has agreed to cooperate with other municipalities to adopt and approve the requisite ordinance and Intergovernmental Cooperative Agreement and By-laws, by creating the Mid Mon Valley Intergovernmental Cooperative for the execution of those municipal functions deemed by CITY OF MONONGAHELA and the Member Governments to be accomplished best through cooperation with each other; and

WHEREAS, CITY OF MONONGAHELA and the aforementioned Member Governments desire that the Mon Valley Progress Council, as the entity uniquely positioned and qualified to facilitate such desired municipal cooperation, be appointed to provide executive, managerial, programmatic and other services to the Mid Mon Valley Intergovernmental Cooperative for an initial period of three years, at which time the appointment shall be reviewed by the governing body of the Mid Mon Valley Intergovernmental Cooperative; and

WHEREAS, the Intergovernmental Cooperation Law of the Commonwealth of Pennsylvania requires that intergovernmental cooperation be established by ordinance by all participating municipalities; and
